Conditions on the Colorado River are worsening at an alarming rate, with reservoir levels dropping to record lows. Meanwhile, new demand for groundwater is leading to declining water tables in some parts of the state. How will changes in water supply alter Arizona's communities and economy? Will the lack of water affect rural and urban communities and industries in the same way? How should water equity and access be determined? What can we do to save water? Can Arizona water users acquire new supplies?

Sarah updated the Club on water issues in January 2020, when she held the Club's rapt attention for over an hour. Join us for a timely conversation about the state's current water challenges and what comes next, while getting answers to the many questions that you, as members and guests, may have today. The meeting will be held at the **East Valley Institute of Technology's Culinary Institute** in **Mesa**, another favorite of the Club. This is a meeting you will not want to miss. Mal spent 38 years working for Delphi Packard Electric in Warren, OH, before retiring in 2007 as a Senior Product Engineer. Following retirement, Mal took on a second career as a facilities director for a large Northeastern Ohio Public School System, where he was responsible for the design and construction of two new school buildings; creating a 100-acre school campus; and the demolition of five old school buildings that no longer met the needs of the community.

After graduating from Austintown Fitch High School, he attended General Motors Institute, where he earned his BS in Mechanical Engineering degree while being sponsored by Packard Electric Division of GMC. While at Packard Electric, Mal worked in various areas, including materials engineering, production engineering, application engineering, component engineering, and engine controls. When Mal retired in 2007, he was a Senior Component Engineer for GM Truck and Corvette.

In October 1972, Mal married Janice, who had also graduated from Austintown Fitch High School. She went on to graduate Cum Laude from Youngstown State University, earning her BS Degree in Elementary Education and Special Education before doing graduate work at Ashland University in Ohio and Southeastern University in Florida. Jan enjoyed her teaching career teaching 1<sup>st</sup> grade and 5<sup>th</sup> and 6<sup>th</sup> grades in middle school, with her favorite classes being math and language arts.

Jan also enjoys reading, exercise, baking and cooking, in addition to shopping, travel, socializing and meeting new people. She was involved with the local Women's Junior League and various church committees while in Northeastern Ohio.

Mal and Jan have two sons and four grandchildren, living in Ohio and Tennessee, providing opportunities for the Culp family to travel several times a year. However, their travels are becoming more difficult as Mal is dealing with kidney function issues and has been on the transplant list at the Arizona Mayo Clinic for two and a half years. **CURRENT MEMBER RIDES OUT HURRICANE IAN**

As we all intently watched the news and saw the devastation that took place last week as Hurricane Ian crossed Florida and moved up the East Coast, virtually all of us knew someone who had connections with the areas involved. Current Club members, Jim and Diane Harshman, survived the ordeal in their home in Palm Coast, Florida, between St. Augustine and Daytona on the east coast of Florida. Jim gives us his first-hand report of the storm and pictures from the area following the storm below.




*“Diane and I would like to thank all of you for your prayers and those who took the time to inquire as to our status after Ian blew through Palm Coast, FL as a Tropical Storm. We are glad to report that we (including the dogs) are fine and in good spirits. However, we did incur minor roof and fascia damage to our house, and the bushes were somewhat torn up. Here is a recap according to the National Hurricane Center for our area as well as some of our own observations:*

- Sustained winds of 65 mph with gusts of 90 mph were experienced.
- 13.5 inches of rain fell.
- Major beach erosion occurred and the famous Flagler Beach Pier completely destroyed. (For those who don't know why that's important...we live 300 yards from the ocean. See pictures below.)
- The ocean “surge” made it to the top of the sandy coast, but did not make the A1A roadway.
- Waves were huge – at least 10 to 15 feet high during the storm which could be seen from our second story windows.
- Lost power and Internet for 4 days. (You know what that means if you have a pump and septic! Right?)
- Some neighbors were not so lucky. Many had roofs partially taken off and lots of siding damage.

*Ian was huge! 400 plus miles across and entered Ft. Myers, FL as a hurricane 4 or 5. Ian's erratic course prevented us from leaving and seeking shelter elsewhere. We couldn't tell where it was going until it was too late to leave. This is our 3<sup>rd</sup> opportunity to dodge a “for sure” storm, so we do understand it's important not to stick around the house to watch one of these. Two years ago we spent four days in Charlotte, N.C.*

*Well, we thank God for keeping us safe and thank you for caring.”*


