NEW CLUB VICE PRESIDENT-LARRY SESSOMS



Larry retired in May of 2008 following 37 years with the GM Legal Staff. As a lawyer, he represented GM in variety of capacities around the world. He served as counsel to our marketing and service organizations in the '70's and '80's, but later in his career was focused on engineering and development, ultimately serving as chief counsel to the EV-1

project, to GM Truck Group under Tom Davis, and to Global Powertrain Group/Advance Vehicle Technologies under Arv Mueller and Tom Stephens. Along with others on teams with which he worked, he received one President's Award (Asia Pacific), and two Chairman's Honors. And he had the privilege of working with, among others in our Club, Jim Irwin and Jon Moss on some of their projects.

Larry was raised in a small community (Arlington, WA) north of Seattle where his grandfather was a lumbering pioneer and his father followed in those footsteps. After breaking his leg skiing when a sophomore at the University of Washington, he transferred to Southern Methodist University in Dallas where he met his wife of 43 years, Faye.

Many of us know Faye, or at least her family. Born in Janesville, WI, Faye, together with her twin sister and younger brother, moved around the country as her father advanced in the ranks of Chevrolet Marketing. Her father, Bill Stacy, retired as Sales Manager-Administrative under Bob Cook. Her brother, Bill, works today as a director with GM central office marketing.

But Larry is clear that Faye's background has little or nothing to do with his GM employment; rather, he credits Ralph Nader. Following the debacle around GM's pursuit of Nader in the late '60's, Ross Malone, immediate past president of the American Bar Association, was appointed GM General Counsel. Ross was on the board of trustees of SMU Law School where Larry graduated in 1971 with a MBA and JD.

Faye and Larry were married following Larry's first year of graduate school and six month's active service in the Air Force National Guard (ahh, Vietnam era...). While her degree was in education, Delta Airlines provided a more lucrative opportunity--Faye worked in Delta sales, handling executive accounts, until their first child was born in 1975. Thereafter she became the ultimate volunteer including as Deacon at First Presbyterian Church of Birmingham, many hours at Beaumont Hospital, and, together with Larry, leadership roles with Scouts.

Faye and Larry have three children: Mark (37), with his wife and two children live in San Diego; Todd (34), together with fellow teacher Jessica, currently reside in Shanghai where they teach at the Shanghai American School (see www.SASChina.org; children of several GM international service personnel are in their classes); Kristy (31), with her husband and two children, reside in Boulder, CO.

The kids all attended colleges outside Michigan, and careers kept them away. So Faye and Larry migrated to Pebble Creek where today they enjoy the Arizona sun and all the activities it allows. As for summers, they are "snowbirds". In 1918 Larry's grandfather built a summer home at Warm Beach on Puget Sound. As Larry says, "you got a neat piece of property in 1918." They have rebuilt that home. But Faye's sister and brother are still in the Detroit area, and they do get back there, typically for Thanksgiving and other special occasions.

Larry is an only child, and all of his earlier generation have passed on. He is named for his father's brother who commanded a landing craft on D-Day. Faye and Larry have a trip planned this coming May to tour Normandy and see the beach where he died that day.

NEW CLUB SECRETARY / TREASURER - ALAN STEFFE



Alan was born and raised in the Saginaw/Bay City, Michigan area. He graduated from General Motors Institute in 1968 with a B.S. degree in Electrical Engineering. He also participated in a General Motors Bachelor's/Master's program at the University of Michigan, receiving a M.S. degree in Electrical Engineering in 1967. He joined General Motors in 1962 as a GMI student at the Saginaw Malleable Iron Plant of Central Foundry Division and quickly moved up the management ranks where in 1973 he was promoted to Maintenance Superintendent.

On November 1, 1975, it was on to the Danville, IL plant where he again quickly moved up the management ranks and became General Superintendent. From 1983 to the day he retired in 2006 he held many varied positions such as; Plant Manager-Massena, New York; Engineering Manager-Chassis & Transmission Business Unit, Central Foundry; Engineering Manager-Castings, GM Power-train; Technical Director-Casting Engineering; Manufacturing Engineering Director - Castings for General Motors Powertrain Group. Alan retired on April 1, 2006.

A highlight in his career was when he was heavily involved in the development of the lost foam process, supporting the development of the process for the Saturn operations while at the Massena Plant and expanding the process from Massena to the Saginaw and Defiance, Ohio, foundries. He received a Service Citation Award from the American Foundry Society in April 2003 recognizing his "managerial and technical leadership in the metal casting industry including high volume lost foam casting processes for the automotive industry." In 2005 he received the William J. Grede Award from the American Foundry Society "for major contributions in the field of management, marketing or education which has resulted in expanding the effective use of metal castings."

Alan is a member of the American Foundry Society, past member of the Society of Automotive Engineers and the North American Die Casting Association, served on the Board of Governors for the North American Die Cast Association, the Board of Directors for the American Foundry Society, the Board of Directors for the Foundry Association of Michigan, the Foundry Educational Foundation Advisory Committee for the University of Windsor, and the Advisory Board for AFS' *Engineered Castings Solutions*. He has been active in civic activities serving on the local United Way Boards and campaigns in Saginaw and Danville, the Junior Achievement Board in Danville, and the Salvation Army Board in Massena.

Alan is active in his local church, serving on various boards and activities, enjoys singing as a member of The Flint Mastersingers, and is involved with several retirees groups in Michigan . He enjoys golf, handiwork around the house, music, sports, and especially activities involving family.

Alan married Eunice Graff from Fowler, Michigan, on July 7, 1969. They met at the University of Michigan, where Eunice graduated from the School of Nursing in 1968. They have three children, all married, and seven grandchildren Eunice passed away in December 2010 following a five-year battle with cancer. Recently, Alan has found another wonderful woman, Roxanne Walker, through his church in Grand Blanc and is looking forward to a July wedding.










Club Member and Board Sub-Director James Shepherd was drafted into the United States Army on July 11, 1966 and was honorably discharged on July 10, 1968. The highest rank he had attained before he retired was Specialist E-5, Pay Distribution Specialist. His units included: Basic Training at Fort Jackson, Columbia, South Carolina, Advanced Training at Fort Dix, NJ (Clerk School) and Fort Benjamin Harrison, Indianapolis, IN (Finance School). Oversea assignment - straight to Vietnam in January 1967 for 11 months and 24 days. Upon arrival in country he was assigned to the First Infantry Division (Known as the "Big Red One"), First Administrative Company which supported the 2/28th Infantry Regiment Bravo and Charlie Company's payroll activity.

Jim demonstrated his bravery and commitment to his country by volunteering to go on monthly "pay runs" which meant flying in by helicopter and picking up the soldier's money and pay records in Saigon and going into the battlefield and paying the troops, no matter where they were located between Saigon and the Cambodian border. Places like Dian, Phuoc Vinh, An Loc, Lai Khe, Bien Hoa, Loc Ninh, Quan Loi and wherever else the 2/28th Bravo & Charlie companies were located in South Vietnam. This area will go down in history as war zone "C". This is where things got a little "dicey"...you just can't go into a "live fire" battlefield unnoticed. Most of the time "pay call" was held in bunkers. Frequently, incoming mortar fire caused a delay in troop pay distribution activities while they dug further into a bunker to dodge flying shrapnel. The hardest part of his Vietnam service was the constant fear of getting killed and the danger involved in the performance of his duties. But the bottom line is..."the troops had to be paid", period! Troop morale was already low in Vietnam, let



alone the thought of not getting paid driving it even lower. If you want to get a feel for the war zone that Jim was exposed to in order to deliver troop pay, Google any of the cities listed above and look at the YouTube footage. Especially "Battle of An Loc" video. Also, Google the "Big Red One" Vietnam - 1966-67 Operations.

Jim's most memorable event that happened during his military career was when the Army granted him a small "military leave" during Basic Training (which is unheard of) to get married to his wife Dolores. You have got to know that both Jim and Dolores were born and raised in Manhattan, NY and wedding arrangements have to be made months in advance and are very expensive to cancel. So, on August 20, 1966 Jim and Dolores were married and have been together ever since. True story, you can't make this stuff up!

Upon completion of his mandatory two year Army commitment, Jim returned to his job at Cadillac Motor Division and for the next 36 years he worked in various Parts, Field and Central Office Sales Management positions throughout the United States. Before his retirement in 2001, Jim's final job title was GM Fleet Account Executive located in San Francisco, CA.



Jim was not what the Army would call a "lifer". He was drafted when he already had a great job at Cadillac, so I am sure he would have preferred not to serve at all, but he did. When a person is exposed to danger day in and day out they become very close to the persons and units they serve with. For the past 20 years, Jim has attended the 1st Infantry Division reunions and for the past 10 years has volunteered as part of the Command Post Hospitality Room setting up the meetings and selling memorabilia at the reunion. Every other year, during the week of October 17, Jim volunteers at reunions for memorial services to acknowledge the greatest loss that the 2/28th Infantry Regiment (Black Lions) ever suffered when Company "A" ran into a regiment of North Vietnamese and

lost. Jim remains a "life member" of the VFW, the American Legion, the 1st Infantry Division and the 28th Infantry Regiment - Black Lions.

In 2002, Jim and Dolores moved from San Francisco to Scottsdale, AZ which is their year round home. Dolores spends her time with her church group (Our Lady of Joy Catholic Church) making "cool scarves" and stockings for our troops in Iraq, Afghanistan and veterans homes in Phoenix area.

NEW MEMBERS-GEORGE AND NANCY HEBERLING



George is a 40 year veteran of General Motors who began his career at the Chevrolet Oakland (CA) Assembly Plant as a GMI engineering student in 1954. Within a short period of time, he became a maintenance and line supervisor at the plant and his career began to take off. Beginning in 1962 - 1973, George began a series of engineering management jobs which allowed him to touch almost all of Chevrolet's platforms both large and small including trucks. He had responsibilities both in the engineering of the vehicle, production and was an expert in coordinating engineers through "fixes" which occurred in assembly. Managing "new vehicle start-up teams" became his specialty.

If we were to ask George what was his greatest contribution to Chevrolet Engineering he would probably say that he was able to lead staffs of engineers that worked for him to ensure that vehicles were designed and engineered that met production standards and got through the assembly plant without a problem. His philosophy was simple; put the designers and engineers together early in the process so they can make sure the pieces fit before being sent to production and assembly. The best example of his expertise is when George brought back the "design check & mockup process" to help and aid engineering and design. He made this part of the engineering process which is still in place today. Prior to this, management thought that all engineering and design could be done on computers, until they began to shut down plants and delay vehicle introductions. His efforts had a major positive impact on improving "Quality" and lowering overall costs. George retired in 1994.

George's most memorable moment at GM was when he ordered and drove the "one and only" aluminum block 1969 ZL1 Chevrolet Corvette built in St. Louis. If George would have decided to buy that car, it probably would have been worth \$3M today. Instead, a drug dealer ended up with the vehicle and lost it when the Government busted him. The Government then sold it at auction for \$450,000.00.

Hobbies include restoring & building "old model cars", "street hot rods" and "dragsters". Travelling in their motor home domestically provides days of fun and adventure as well as foreign travel to such places as Europe, China, Thailand, South America (Peru, the Amazon, Machu Picchu and Galapagos). Next up is Turkey and Uzbekistan this Spring.
