YEAR-END FINANCIAL REPORT

Financial records for our Club are maintained on a meeting-year basis, running May through April. With that understanding, the Club finished the 2013-2014 year on April 30, 2014, with a bank balance of \$8,161.32. Income during the year comes basically from two areas – dues and the 50/50 raffle proceeds in the ratio of 80% from dues and 20% from the raffle. Last year 52% of the dues received went toward subsidies for monthly luncheons and meetings, including venues, speakers, and entertainment, in order to help keep our meetings affordable. The remainder of the dues and raffle income cover normal Club operations such as copies, mailings (principally to those members not on email), Board meetings, honoraria, and future program planning. As of December 3, 2014, our Club has a financial balance of \$8,530.70.

The club dues of \$30.00 per year, which are currently due to Jim Irwin for the 2015 year, are very important to our Club in that they are used in great part to subsidize and keep monthly meeting luncheon fees at the lowest possible amount. Similarly, the Club's support of the 50/50 raffle at the monthly meetings also helps keep the dues as low as possible.

As our Club By-Laws (Sec. VIII(5)) require, an audit of our financial records was conducted on November 12, 2014 by an Audit Committee appointed by Club President, Larry Sessoms, consisting of Hal Hubbard, Bill Boechler, and Jorge Medina. Their findings noted that the financial records are accurately being recorded and maintained.
