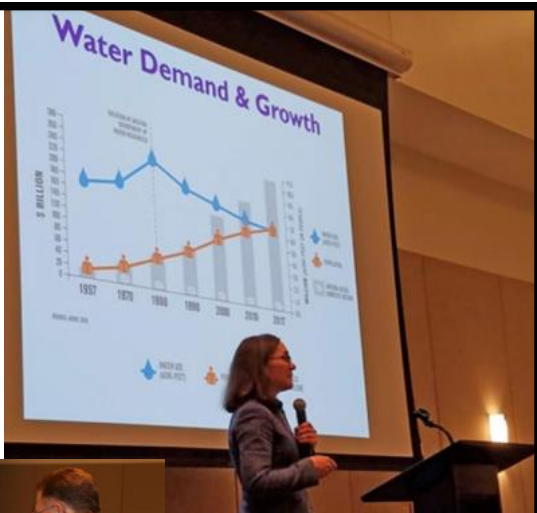
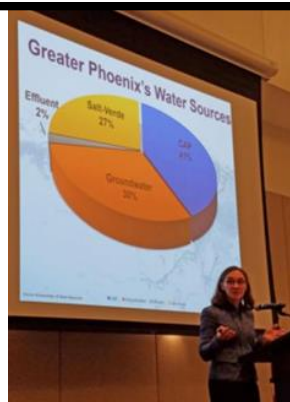

JANUARY MEETING SUMMARY

Sarah Porter, Director of the Kyl Center for Water Policy at the Morrison Institute at Arizona State University, gave an outstanding presentation regarding the water issues facing Arizona – the background issues of the sources of water, where the water goes, how the allocation of water is handled, how growth is impacting water availability, water reuse and banking, and the future outlook for various locations and needs in Arizona. She held everyone's close attention as she concluded by noting that the Arizona water situation is about haves and have-nots, who are creating increased competition for available water resources. Namely, it's all about politics.

DENNIS ARTHUR POWERS OBITUARY



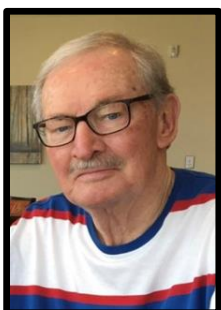
